Invoices are due by the 10<sup>th</sup> of the month following date of month end invoice. Accounts paid after the 25<sup>th</sup> are subject to a 2 % per month (24% annual rate) service charge. Any returned checks will have a handling fee of \$35.00. Any customer with two or more NSF's will be placed on cashier's check only bases. All returned merchandise would have a 15% restocking charge. Special order merchandise will not be accepted for return and require a 50% Deposit at the time of Order (to include Andersen & Eagle Windows, as well as Vista Point Doors.) If your account credit limit is reached, you'll be expected to prepay until the balance is brought down within the terms of our agreement.

**We understand that these Net 10<sup>th</sup> terms of payment, are not contingent in any way of payment by the owner in time or amount. (This is not a Building Contract or Subcontract agreement.)**

**Changes to install dates that are made after materials have been ordered, and that delay the installation into the next billing cycle, will require a progress payment to cover material cost.**
